
Our Question.

Is a lack of available workforce housing (up to 120% median income) a drag on economic development?

What We Heard.


- High demand for rentals and residential family real estate
- High demand contributes to higher costs and lower value in both (rental and purchase) markets
- A low rate of new construction, with many contributing factors, contributes to the shortage
- Humboldt's cannabis industry has had a significant impact on both markets. But is that still true? What about vacation rentals?
- Limited ability to change conditions at local level, but local changes can be made.
- Housing quality is an issue. Some older homes and apartments may not be attractive.
- Housing policy is made jurisdiction by jurisdiction.






