- A. Report on Process for Updating the Humboldt County Comprehensive Economic Development Strategy (CEDS): Executive Director gave an update on the County's update of the CEDS and the RREDC led meetings on community infrastructure projects.
- B. A. Presentation of Draft Audit for FY 2009-2010: Mark Wetzel, CPA, David L. Moonie Co. presented the draft FY 2009-2010 audit. The final audit will be adopted at the March 28, 2011 meeting.

- **B. Presentation of Draft FY 2012 Budget:** A copy of the draft budget for FY 2011-2012 was distributed. No action needed at this time; a public hearing will take place at the March 28, 2011 meeting. The final draft of the budget must be adopted at the April board meeting.
- **C. Discussion of Potential for New Microloan Program:** The slow economy has resulted in fewer loan inquiries and suitable loan requests. The idea of having a fund for smaller loans, with a streamlined application/approval process was discussed. Members were asked to give staff any ideas they have for new loan products.
- **D.** Reappointment of Loan Committee Members: The RREDC loan committee is made up of three members each from 1) banking/financial institutions, 2) small business owners and 3) the RREDC board. There is also one member-at-large position.

The following loan member terms ended February 28, 2011: Phil Sullivan, banking/finance; Liana Simpson, small business; Frank Scolari, RREDC board. M/S/P: Wilson/Fulkerson to approve reappointment of Sullivan, Simpson and Scolari to the RREDC Loan Committee for the term of March 1, 2011 to March 1, 2013.

This leaves two vacancies in the RREDC board category. The member-at-large position is also vacant.

M/S/P: Wilson/Stillman to nominate Bruce Rupp to represent the RREDC Board of Directors on the loan committee for the term of March 1, 2011 to March 1, 2013.
